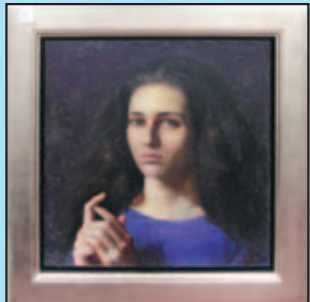

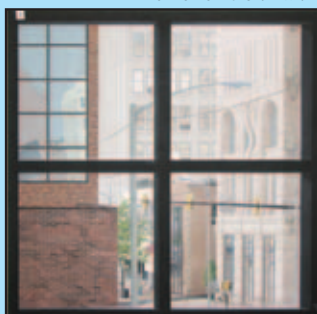

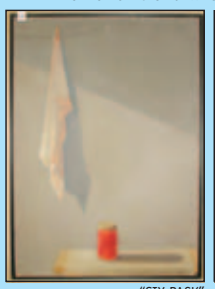

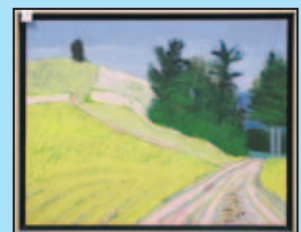

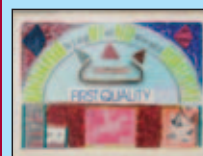

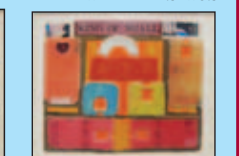
"3 KING OF SMALL"
