**FROM I-91 NORTH:** TAKE THE US-5 S EXIT 1, TOWARD LONGMEADOW. APPROX. 0.4 MILE. STAY STRAIGHT TO GO ONTO US-5 S / COLUMBUS AVE. CONTINUE TO FOLLOW US-5 S. APPROX. 0.6 MILE. TURN LEFT ONTO CONVERSE ST. APPROX. 2.3 MILES. TURN RIGHT ONTO DWIGHT RD. APPROX. 0.2 MILE. DWIGHT RD BECOMES BENTON DR. APPROX. 0.6 MILE. TURN LEFT ONTO CHESTNUT ST. APPROX. 1.9 MILE. TURN RIGHT ONTO SOMERS RD / RT-83. APPROX. 0.6 MILE. TAKE THE 2ND LEFT ONTO HAMPDEN RD. APPROX. 1.4 MILE. HAMPDEN RD BECOMES E LONGMEADOW RD. APPROX. 1.2 MILE. TURN RIGHT ONTO SOMERS RD. (WATCH FOR AUCTION SIGNS).
